Categories of Membership:

Documents required:

- a) Hard copy of Duly filled in, signed and stamped application form.
- b) Proof of Machine Manufacturer like MSME Certificate of machine manufacturer and Last two years Trading and P&L Account copy (Duly attested by CA).
- c) Memorandum and Articles of Association.
- d) PAN Number and GST Number.
- e) Recommendation letter from one IPAMA Regular Member.
- f) Company's Brochure.
- g) Proof of Registered and Factory Address.
- 2. Associate members will consist of persons, firm or body corporate associated with Trading or engaged in the field of Printing, Packaging, Signage, Digital, Allied Machinery & Materials and trades like Advertising agencies or organization with aims and objectives related with or similar to those of the Association, the Governing Council may consider eligible.

Documents required:

- A) Duly filled in, signed and stamped application form.
- B) Documents supporting that the Company is engaged in the trade of Printing, Packaging and allied Material.
